OLD BUSINESS

CGS TRASH SERVICE – Town Manager researched adding the residential trash service to town services and billing the residents same way as sewer. The cost to add the module to Keystone billing is \$900.00 plus all other administrative costs to be determined and notification to residents would need to be done. The trash service could be put out to bid with stipulations on what services it would entail. Chris Ross representative from CGS also in attendance. Town residents Marcia and Carl Andry 10 E. North St. voiced their complaints and concerns with service as it is now with trash pickup being missed too often.

Jan Jarson made the motion to approve Dave Book to look into letting bids for town trash services. By general consensus the CGS trash pick-up will remain Tuesdays as determined January 17th meeting until a new service can be approved.

Jan Jarson made the motion to accept the 2019 property, casualty & workers compensation insurance with Selective Insurance and IPEP. Brandee Bastin seconded and the motion carried with 3 ayes and 0 nay.

TRANSFER RESOLUTION #020318A RAINY DAY- Clerk-Treasurer Becky Hilligoss read Transfer Resolution #020318A transfer funds from General to of Rainy Day. Clint Bledsoe made the motion to pass Resolution #020318A. The motion carried with 3 ayes and 0 nays.
