The New Palestine Town Council met on Saturday June 7, 2014 at 8:00a.m. at the New Palestine Town Hall. Jan Jarson called the meeting to order with Clint Bledsoe and Larry Jonas in attendance.

Minutes –Clint Bledsoe made the motion to accept the minutes of May 21. Larry Jonas seconded and the motion carried with 3 ayes and 0 nays.

OLD BUSINESS

SNOW REMOVAL-Larry Jonas made the motion to approve a Snow Removal List for contractors on stand-by to help the town in snow situations. Clint Bledsoe seconded and the motion carried with 3 ayes and 0 nays.

STREET LIGHTS- Town Manager David Book met with INDOT in Greenfield for the pre-construction meeting including DLZ and Morphey. The construction will start after 7-1 and poles will be up sometime mid-August. Banner height was discussed with the decision of bottom of flags and banners be 10 feet.

GEM ROAD SIDEWALK-Town Manager David Book reported that the Phase II for Gem Rd. sidewalks will go to bid in a week and half. Cedar Creek handicaps ramps will be fixed with this phase.

NEW BUSINESS

DRAIN REPAIR WILSON DR.- Larry Jonas made the motion to accept the bid with Fisk Services for \$ 8,955.00 for the drain repair at Wilson Dr. out of the 2 quotes received. Clint Bledsoe seconded and the motion carried with 3 ayes and 0 nays.

EAST SIDE POLICE AWNING- Clint Bledsoe made the motion to approve the quote for Little Construction for \$3,355.00 to repair the awning soffit on the east side of the police building. Larry Jonas seconded and the motion carried with 3 ayes and 0 nays.

WASTEWATER MANHOLE REPAIR- Larry Jonas made the motion to approve Spectra Tech to repair 2 manholes at force main connections along Larrabee St. for the wastewater department for \$5,737.00. Clint Bledsoe seconded and the motion carried with 3 ayes and 0 nays.



SCOUT-Troop 244 Scout Christopher and Nicholas were in attendance for their Communications Merit Badge.




The meeting was then adjourned by motion from Larry Jonas and seconded by Clint Bledsoe motion carried with 3 ayes and 0 nays.
