The New Palestine Town Council met on Saturday August 2, 2014 at 8:00 a.m. at the New Palestine Town Hall. Clint Bledsoe called the meeting to order with Larry Jonas in attendance. Jan Jarson absent.

Minutes –Larry Jonas made the motion to accept the minutes of July 16. Clint Bledsoe seconded and the motion carried with 2 ayes and 0 nays.

**OLD BUSINESS**

**STREET LIGHTS-** Town Manager David Book met with others to try to straighten out the problems of the light poles and will hear shortly what can be done.

**GEM ROAD SIDEWALK-**Town Manager David Book reported that the re-bid for Phase 2 Gem Rd. sidewalks will be Tue 8-5 at 9am.

**SALT STORAGE BUILDING-** Sewer Manager Dave Book stated that the dirt and stone work had been done by Crim & Sons this week.

**STREET PAVING-**Town Manager Dave Book reported that 99% of the street paving was done this week.

**NEW BUSINESS**

**MARY M. NICHOLS COMM. LIBRARY BUILDING** – Town Manager Dave Book presented the quit claim deed and sales disclosure forms to be able to accept the Mary M. Nichols Comm. Library building from the Foundation who have offered the building to the Town of New Palestine at no cost.

The building is in good shape with the exception of the windows and some outside painting and a little brick work. Frey Construction quoted \$12,299.40 for the work needed to put the building in good shape. Larry Jonas made the motion to accept the building donated from the Mary M. Nichols Comm Library Foundation. Clint Bledsoe seconded and the motion carried with 2 ayes and 0 nays. The sales disclosure form was signed by Clint Bledsoe Vice President.




